#### Rules for Visitors:

- The Cemetery is open to visitors at all times between the hours of sunrise and sunset. Permission to enter the cemetery at any other time must be obtained from the Cemetery Sexton or Police Department.
- Persons /picnics with food/refreshments will not be allowed in the Cemetery.
- Firearms will not be allowed at the Cemetery except at military funerals.
- Visitors are required to use the walks and drives and are forbidden to trespass on Cemetery lots; pick any flowers (either wild or cultivated); injure any shrub, tree or plant; or mar or deface any monument, stone, or structure in the Cemetery.
- Vehicles traveling in the Cemetery shall proceed at a speed not to exceed fifteen (15) mph.
- The Cemetery prohibits spreading of ashes above ground.
- Snowmobiles are not allowed in the cemetery.
- Dogs will be permitted on the roadways; however, they must be cleaned up after and the owner must be in control.

#### Cemetery Clean Up:

During each clean-up, ALL decorations will be removed from the Cemetery, EX-CEPT those in a permanent vase (on the stone or foundation), saddles on stones, and shepherds hooks placed next to the foundation.

The following clean-ups take place annually: SPRING: 3rd full week of April MEMORIAL DAY: 2 weeks following Memorial Day FALL: 3rd full week of October

#### Vegetation/Plantings:

- ALL landscaping (including the planting of trees and shrubs) will be done by the Cemetery.
- Fresh cut flowers (and those in temporary containers) may be used and will remain until (at the discretion of the Cemetery Sexton) they become wilted/ unsightly.
- There will be NO in-ground vases allowed in the Cremation Garden.
- Potted plants, in an acceptable container, may be used and remain until the Cemetery Sexton judges them to be unsightly.

The Cemetery Sexton, without notice, may remove vegetation that has been planted on lots not in conjunction with the rules/regulations and has not been maintained.

#### DO NOT USE:

- 1. Glass, clay, or pottery containers.
- 2. Pieces of wire or similar bindings to secure baskets or pots at any time. This can create dangerous situations for staff performing maintenance duties.

#### CEMETERY LOT FEES

Full payment for the purchase of lots/niches is required at the time of sale; however, if necessary, monthly payments may be arranged at the time of purchase. There will be an additional \$5.00/month added to scheduled payments for administrative fees. Payments must be completed within one (1) year from the date of down payment. If payment in full is not made within one year all monies will be forfeited. There will be no burials permitted until payment is made in full.

Twenty-five percent (25%) of the price of any space for in ground burial will be entered into the Perpetual Care Fund. Twenty percent (20%) of the price of any niche space will be entered into the Perpetual Care Fund. Five percent (5%) of the price of any niche space will be entered into the Columbarium Maintenance Fund.

Standard Burial Space.....\$600.00 One standard vault burial, two in-ground cremain burial urns, or one two-niche columbarium may be placed in or on one standard burial space. Cremain burials on existing inground lots are allowed only with the permission of the Sexton.

Two cremation burials with one standard vault burial or three in-ground or above-ground cremation burials with no standard vault burial. Cremation burials on existing in-ground lots are allowed only with the permission of the Sexton.

Infant package to be used in Babyland......\$575.00 Marker, space, and grave opening/closing included. All stones in Babyland are one size, one color, and furnished by the Cemetery. Burial containers cannot be larger than 36" long by 18" wide.

#### Interments/Inurnments:

- The Cemetery Sexton shall be given twenty-four (24) hours notice in the summer and forty-eight (48) hours notice in the winter prior to grave opening and preparation of the interment.
- NO SUNDAY BURIALS unless religious practices require otherwise. ٠
- All interments shall be in a concrete vault. ٠
- All grave openings and closings shall be made under the direction of the Cemetery ٠ Sexton. Persons ordering grave openings will be held responsible for payment per the established fees and charges in Appendix A of the Nevada Municipal Code.
