1. Call to Order

The City Council of the City of Nevada, Iowa, met for a regular meeting in the Council Chambers located at City Hall, 1209 6th Street, Nevada, Iowa. Mayor Lynn Lathrop, convened the meeting at 6:04 p.m. on Monday, July 28, 2014, pursuant to the rules of the Council. Ray Schwichtenberg reported on the NEDC meeting. They are continuing their membership drive and have appointed two new board members, Brett Barker and Doug Anthony. There are some prospects looking at property in the West Industrial Park.

Jane Heintz and Brian Hanson reported on the City/School meeting. Grant money is being sought for the repairs at Billy Sunday Field. A community garden is being considered south of the elementary. DMACC is looking to partner with Nevada School to implement a welding program. Discussion was also held on the SCORE Crow's Nest, gym space and security at the middle school.

Lynn Lathrop updated the council on the Community Betterment Committee. They are reviewing plans and narrowing down the details and green space. The next meeting will be August 4^{th} .

- A response was received from CIWA. An agreement with be prepared.
- Region XII will host a meeting with local realtors, bankers, and economic development to give an overview of the housing program Tuesday, August 12th.
- One bid was received for the 1986 Pierce Rescue Truck for \$8,500 from the City of Hopkinton, Iowa.

Shawn Cole thanked everyone for helping out while he was gone on vacation. Valley View is scheduled to be paved tomorrow. They are working on sewer at C Avenue. Projects are going well. Indian Ridge pressure tests passed and they are waiting on road design.

Mike Neal reported 11th Street will be poured this week. No other homes were affected by the sewer backup, this will be a teachable moment.

Tim Hansen advised staff is working on field projects. Pool is scheduled to close on August 17th, but they will be short staffed because of the start of school so some areas may be closed. The main objective is to operate safely.

Ray Reynolds reported the fire station doors have been installed. A few fire hydrants have been painted. Communication within the city is great. Several comments from council agreed the station was looking good. The fire department has implemented a fitness test for new members.

Ric Martinez advised they are working on a trespass issue. Koch is no longer an officer with the department. It will probably be January before the position will be filled.

Kerin Wright reported the auditors are tentatively scheduled for the end of August. Staff is busy covering for vacations and she thanked everyone for helping out.

Jeremy Huntsman was asked about the trail repair and if fill and seal cracks were the best option. Overlay isn't necessary for the trail. He will look into it. Valley View Circle should be driveable by the end of the week. Chris Clark asked if the north side of tracks on 6th Street should be included in the repairs. Huntsman explained that there is curb and gutter there and it would require a different process.

Erin Clanton reviewed a section of the Standard Operating Procedures for the Nevada City Council. It is the intent to review a small portion at each meeting. The review was on Open Records. Anything within the city is an open record, but there are a few exceptions.
